

Visitor Visa for Qatar

For those visiting Qatar, the Qatari government issues visitor Visas valid for 3 weeks for Businessmen, managers, skilled staff and tourists on arrival at the airport for the following 33 nationalities:

If you have time prior to your travel, you may get your visa at any Qatari Embassy world-wide.

Conditions of Visa:

1. This Visa facility and the above list of 33
2. The government charges QR 100 (approx. US\$30) for issuing the initial visitor visa on arrival, valid for one month with option of extending by another month only by paying additional QR 100/-. Thereafter, a penalty of QR 200/- per day is applicable for stay beyond 2 months.
3. The visitor's visa should have a passport validity of minimum six months.

Visa Issuance Procedure:

Upon Arrival please locate the Visitor Visa Counter in the arrival hall and obtain an **Instant Visa Request form** (similar to the sample below) which you will need to fill out with relevant personal information as well as information of the company or organization you are visiting.
